



Privacy Policy

This Privacy Policy explains how the law firm collects, uses, and safeguards your information when you visit the website and choose to use the contact or intake form. 1. Information We Collect

When you use the firm's intake or contact form, you may choose to provide:

- Your name
- Email address
- Phone number (optional)
- Any other information you include in your message

Submission of a phone number is not required for the review of your inquiry.

2. Use of Phone Numbers and Text Messaging

We value your privacy and want you to understand how your phone number is handled:

- No Sharing of Phone Numbers: Your phone number will NEVER be sold, rented, traded, or disclosed to third parties for marketing, sales, or any other non-legal or unrelated purpose. Strict confidentiality of all contact information is maintained at all times.
- No Unsolicited Texting: The law firm does not use text messaging to initiate contact with website visitors or prospective clients.
- Responding to Inquiries Only: If you include your phone number and send us a message, the firm may respond via text only if you initiated contact and a text is an appropriate response method.
- Client Consent for Ongoing Text Communication: If you become a client, you will be asked to confirm your preferred method of communication. Text messaging will only be used if you expressly consent to that method of contact.
- Message Frequency: The law firm does not send mass text messages or promotional content.
- Opt-Out: You may opt out of text message communication at any time by notifying the firm in writing or replying "STOP" to any message, if applicable.

3. Confidential Client Information and Limiting Shared Information

You are encouraged to limit the details you share on the intake form to only what is necessary for our initial review (such as the general nature of your legal issue). Do not send confidential, sensitive, or time-sensitive information through the website.

Communications, including your name and information shared, are confidential regardless of whether users of the website or senders of messages to the firm are retained or become clients of the firm.

4. Data Security

The firm uses reasonable administrative, technical, and physical safeguards to protect any information you submit through our website from unauthorized access, use, or disclosure. However, no method of transmission over the Internet or electronic storage is 100% secure.
